Culture & Globalisation

Globalisation, an inalienable aspect of contemporary life, has not only had an enormous impact on the economic, political, technological or legal landscapes of societies but has also proved to be a significant factor in the shaping of culture and how cultures interact with one another. With the expansion of the internet and changing structures of international travel and immigration, the forces that shape and control the patterns of global economic chains also have a profound impact on how the transmission of ideas, values, ideologies, and cultural practices takes place. Hypothetically, as per the advocates of the free market, the exchange and encounters take place on a level playing field. In practice, however, as critics of globalization point out, with the emergence of the existing world order from the colonial through to the neocolonial times, exchange of any kind, be it cultural or trade, is neither free nor equal.

One of the central debates in the sociology of globalisation revolves around whether globalisation leads to cultural homogenisation or hybridisation. Scholars like George Ritzer, in his concept of McDonaldization, argue that globalisation promotes a standardised, consumer-driven culture, eroding local traditions and creating a homogenised global culture. On the other hand, theorists such as Homi K. Bhabha emphasise cultural hybridity, suggesting that globalisation fosters the blending of cultures, resulting in new, dynamic forms of cultural expression thereby highlighting how local cultures reinterpret and adapt global influences, creating unique hybrid identities. Roland Robertson introduces the concept of glocalisation, which describes how local cultures actively engage with global forces to assert their distinct identities. This is evident in movements to preserve indigenous languages, traditions, and practices in the face of global cultural dominance. For example, the Zapatista movement in Mexico exemplifies how local communities resist globalisation while simultaneously leveraging global networks to amplify their cause.

Globalisation also raises ethical questions about cultural appropriation, authenticity, and representation. Sociologists like Stuart Hall have explored how globalisation complicates notions of cultural identity, particularly for diasporic communities. The tension between cultural exchange and exploitation is a recurring theme, as seen in debates over the appropriation of indigenous art or the commercialisation of religious practices. The dynamic relationship between culture in practice and the phenomenon of globalisation is a window to understanding how societies adapt, resist, and evolve in a globalised world.
